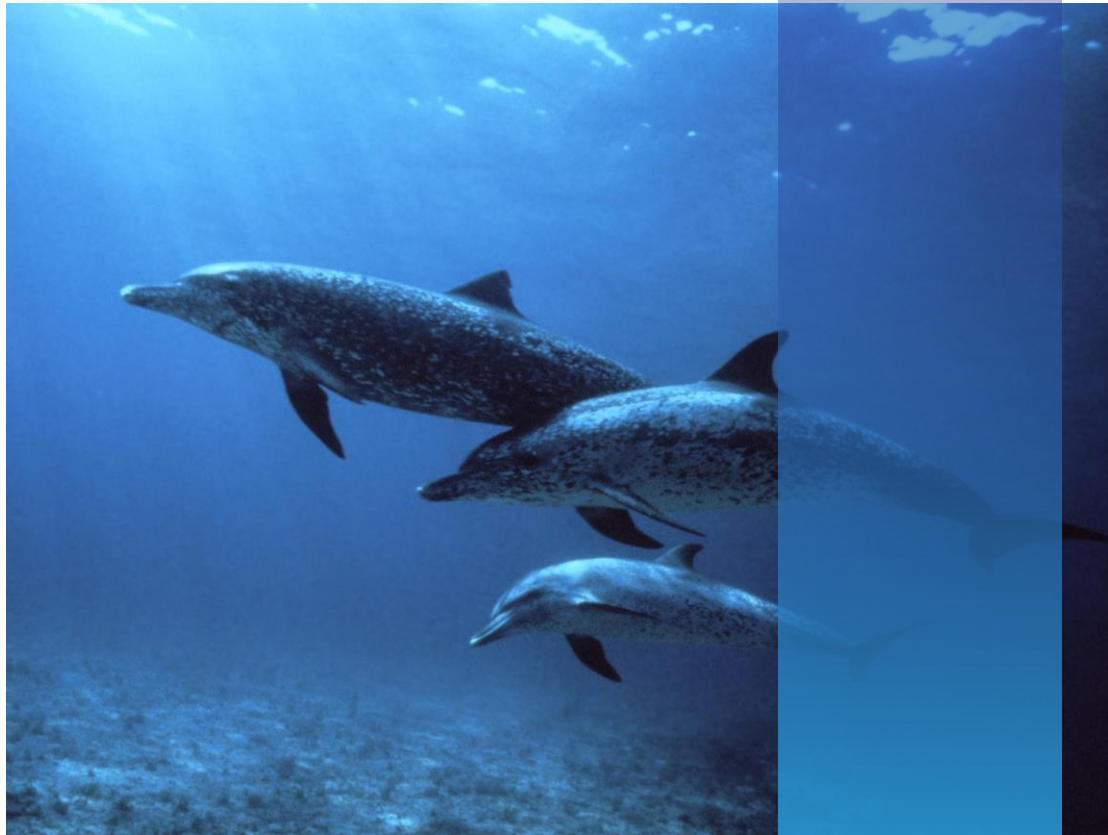

Required for all business entities storing, processing, or transmitting cardholder data, it was developed to ensure that credit merchants and service providers maintain highest information security standards. Customers who implement PCI guidelines generally operate with a higher level of quality, and improved overall risk management, resulting in an improved customer experience and reduced number of avoidable incidents; PCI recommends that IT ensure that the right access is provisioned to the right people, according to functional roles. We should ensure that we have an accurate account of inventory of digital access assets, identity digital access entitlements to ensure network security. PCI DSS, establishes a set of information security goals and requirements that include:

1. Build and Maintain a Secure Network and Systems
2. Protect Cardholder Data
3. Maintain a Vulnerability Management Program
4. Implement Strong Access Control Measures
5. Regularly Monitor and Test Networks
6. Maintain an Information Security Policy
